



AWARDS OF THE ORTHODONTIC SOCIETY OF GREECE

The Orthodontic Society of Greece, with the aim of strengthening research activity by junior colleagues, has established excellence awards.

1. **The Greek Orthodontic Society award for the best oral presentation** at the annual National Congress of the Greek Orthodontic Society and the Orthodontic Society of Northern Greece [500€], and
2. **The Greek Orthodontic Society award for the best e-poster presentation** at the annual National Congress of the Greek Orthodontic Society and the Orthodontic Society of Northern Greece [300€].

The awards for excellence are given to principal investigators who have carried out research or clinical work on orthodontics.

Terms and conditions of participation:

1. The principal investigator should **NOT** exceed 45 calendar years of age and **should NOT** hold an academic rank higher than the Assistant Professor.
2. Each chronological year, the principal investigator may apply only for one of the above prizes and with one participation. The research team that will submit the participation may include more members, but only should have the role of the principal investigator from the beginning.
3. The candidate oral / e-poster presentation may involve any clinical and / or research issue related to Orthodontics.
4. The oral / e-poster presentation will be conducted in English.
5. A prerequisite for participation in the competition is the pre-registration of the principal investigator at the Congress.
6. The selection of the candidate presentations will be made by a Scientific Committee, which will be selected by the Board of Trustees of the Greek Orthodontic Society. The awards are conferred the annual National Congress of the Greek Orthodontic Society and the Orthodontic Society of Northern Greece, which is organized in Athens and takes place during the event.
7. Each of the prizes for the same work may be awarded equally to two researchers, provided that the second researcher meets the age and academic requirements such as the principal investigator.
8. In the event that the Scientific Committee deems two nominated papers to be equal, it is possible to distribute the prize equally to the two respective principal investigators.

9. The judgment of the Scientific Committee is final.

After evaluating the abstracts, the selection of the best oral presentation follows, which will be presented in a special session of the National Congress of the Greek Orthodontic Society and the Orthodontic Society of Northern Greece during which the final selection of the best announcement will be made by the jury.
